

WAIVER AND RELEASE OF LIABILITY

HB Hoops Youth Basketball League

By signing this Waiver, Consent to Assume Risk and Release of Liability, henceforth referred to as the "Waiver", I have consented to execute this Waiver. I further acknowledge and understand that neither **HB HOOPS LLC** nor **ANTHONY FERRISO** shall be held personally or legally liable for any injuries, damages, or losses incurred as a result of participation in the League.

Voluntary Participation:

I affirm and acknowledge that my participation in the **HB Hoops Youth Basketball League** is completely voluntary, and I am fully aware of the nature of the activities and the risks involved. By choosing to participate, I accept full responsibility for any decisions made during my engagement in the League's activities. Likewise, **I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR RISKS, INJURIES, LOSSES, COSTS, AND DAMAGES ARISING THEREFROM.**

Assumption of Risk:

By affixing my signature to this Waiver, I hereby willingly acknowledge and accept that participating in basketball activities, including practices and games, involves potential risks such as, but not limited to, physical injury, illness, collisions, falls, or other incidents. By signing this Waiver, I knowingly and voluntarily accept all risks associated with participation, whether known or unknown.

Medical Consultation:

I affirm and acknowledge that I have consulted with a healthcare provider regarding my physical aptitude to participate in basketball activities and will follow all recommendations provided by my healthcare provider regarding participation in the League.

Waiver and Release of Liability:

By signing this Waiver as the Participant, I, on behalf of myself, and my representatives, heirs, family members, and assigns, release and discharge **HB HOOPS LLC, ANTHONY FERRISO, ANTHONY LEONE, PETER PANTOJA, DAVID RODRIGUEZ, AND ST. HELEN'S CHURCH (157-10 83RD ST, HOWARD BEACH, NY 11414)**, their employees, agents, and representatives, from any and all legal claims, demands, actions, or causes of action arising from any injury, damage, or loss incurred during participation in the League, even if caused by negligence. I, for myself and my representatives, executors, heirs, family members, successors, and assigns, hereby expressively and willingly agree to waive, covenant not to sue, release and discharge **HB HOOPS**

LLC, ANTHONY FERRISO, ANTHONY LEONE, PETER PANTOJA, DAVID RODRIGUEZ, AND ST. HELEN'S CHURCH and all of its officials from any and all liabilities, loss, cost, damage, expense, claim, and suit.

Indemnification:

I also agree to keep the **HB HOOPS LLC, ANTHONY FERRISO, ANTHONY LEONE, PETER PANTOJA, DAVID RODRIGUEZ, AND ST. HELEN'S CHURCH**, its officers, directors, employees, agents, and officials harmless and indemnify against any and all claims, actions, suits, charges, expenses, damages, and liabilities, including attorney fees, resulting from actions, errors, or omissions, or as a result of, any misrepresentation, negligent act or omission, or failure to comply with any laws or regulations under the conditions specified herein.

Audio and Video Recording Consent:

I understand that the League may use audio and video recording devices for security and operational purposes, and I consent to be recorded while on the premises or during activities related to the League.

Agreement:

- The intent of this Waiver is to be as wide and inclusive as the laws of the state of New York allow. If any provision of this Waiver is held by a court of competent jurisdiction to be invalid, void or unenforceable, then only the portion of that provision held invalid, void or unenforceable shall be stricken, and the remaining provisions shall, nevertheless, continue in full force and effect without being invalidated in any way.
- I acknowledge that I am over the age of 18, that I have read and completely understand these terms, that I have relinquished significant privileges and rights by signing it, that I have endorsed it freely and without any enticement or guarantee of any kind, and that I intend it to be a complete and unconditional release of all liability to a great extent allowed by law.
- If the instant Waiver is executed on behalf of a minor Participant, I hereby affirm and acknowledge that I am the parent or legal guardian of the Participant. My signature on this Waiver shall have the same legal effect as if the Participant had signed for itself, and I agree to all terms and conditions outlined herein on behalf of the minor Participant.
